2.	Specifications	<p>Material: JUCCO Fabric/Voila Jute</p> <p>Dimensions: 13" X 15" (Width X Height), Gadzzet - 6", Handles- 16" (Handles should be Nawar type with loaded rope). The dimensions of the bag should be exclusive of the cloth border.</p> <p>Colour: Width and Height Natural Shade Gadzzet - TSCAB Green</p> <p>Others: Non-Woven lining inside the bag, Zip (8 Number) and runner should be of good quality. Strip of 5.7cm Height and 13" Width in TSCAB Green Colour, placement of the strip – with a gap of 5.30 cms from the bottom on both sides.</p> <p>Printing: Logo and Bank name as specified by the Bank in multi-colour.</p> <p>Stitching: Double Stitch with good quality thread, as per the sample provided by Bank.</p>

3.	Delivery Schedule and Packing	Each bundle consisting of 25 Bags in sets of 100 Bags packed in suitable Cartons to be delivered in the Bank's premises within 20 days from the date of submission of final proof by the Bank. In case of non-adherence to the delivery schedule, the Bank reserves its right to cancel the entire work order without any further communication and without assigning any reasons therefor. The Bank will pay no charges (freight, handling, transportation etc.,) for delivering the goods.
4.	Design and Lay out	Design samples (3 to 4 times) are to be submitted to the satisfaction of the bank before final approval. The final approved sample shall be jointly signed by the Bank and the firm before executing the order. The order executed should be in accordance with the sample approved.
