1. Quantity	:	6000 Units (Six Thousand only)
2. Specifications	:	Material: Foam Rexin Colour: Brown (as per the sample) Size: 10.5 cm * 16.5 cm Inner Specifications: Bi-fold debit card holder with in-build three card slots on both the sides. Stitching: Stitching should be of fine thread and neatly stitched. Logo Embossing: Bi-punch heat processing. In case of any ambiguity in the specifications mentioned above, the same shall strictly be as per the sample provided by Bank. (Sample will be available with PR Dept. - Apex Bank, HO during office hours from 10.30AM to 05.30PM)
3. Delivery Schedule and Packing	:	Each Debit Card Holder should be packed in polythene cover and to be delivered in packed cartons at Bank's premises with sets of 100 Debit Card Holders each within 15 days from the date of submission of final proof by the Bank. In case of non-adherence to the delivery schedule, the Bank reserves its right to cancel the entire work order without any further communication and without assigning any reasons therefor. The Bank will pay no charges (freight, handling, transportation etc.,) for delivering the goods.

4.	Design and Lay out	:	Design samples (3 to 4 times) are to be submitted to the satisfaction of the bank before final approval. The final approved sample shall be jointly signed by the Bank and the firm before executing the order. The order executed should be in accordance with the sample approved.

TERMS & CONDITIONS:

1. The firm should be in existence for a minimum period of three (3) years and should have their own manufacturing unit. Physical verification of the manufacturing unit will be done by the Bank before release of Work Order. (Copy of Certificate of Incorporation issued by Municipal or other competent authority and Labour certificate to be enclosed).
2. IT returns of the firm for the last 3 years to be enclosed.
3. The firm should have executed the orders of similar quantity previously (Copy of previous Work order to be enclosed).
4. The firm shall submit a copy of Firm's PAN Card, Address proof, GST Number along with quotation.
5. **The firm has to submit DD/BC towards EMD for an amount of Rs.10,000/- in favor of "Telangana State Co-operative Apex Bank Ltd." Payable at Hyderabad. Quotations received without DD/BC will be rejected. The EMD will be refunded only after the total goods are delivered.**
