2. Model	:	Model : Milton Unisteel Super 750 ML Single walled SS Bottle Logo Embossing: Logo should be printed on the bottle.

Delivery Schedule and Packing	:	Each Bottle should be packed in separate box and to be delivered in packed cartons at Bank's premises with sets of 50 Bottles each within 15 days from the date of submission of final proof by the Bank.
